

2017 Pine Lane Campground

Overnight Guest Rules, Regulations and Guidelines

Please read, and obey the rules. Make the outdoor experience a pleasurable one for all campers. If you have any questions regarding these guidelines please see management. We reserve the right to evict without prior notice anyone who creates a disturbance or inconvenience. No refunds of fees will be made in such event.

- **May 5, 2017** is opening day for the campground.
- Rates: Travel Trailers, RV's etc.: site \$40.00/per night (Holidays \$45.00) Tent Sites (**1 tent per site**): \$35.00/per night (Holidays \$40.00) additional tents will pay tent site rates. Electric & Water on all sites.
- Rate is figured on 2 adults, & 2 children; additional children ages 3- 9 \$3.00 per night (age 2 & under free), additional guest 10 and over \$5.00 per night.
- Minimum stay of two (2) nights on Holiday weeks
(Memorial Day, Fourth of July and Labor Day)
- Hours of Operation: Check in **1:00pm to 8:00pm** * **Check out 11:00 am.**
- Campground Speed Limit **10 mph**
- Visitors of overnight campers **must register and pay** the visitor's fee of \$3.00 per day and \$5.00/per person if overnight stay. Overnight campers are responsible for their visitors.
- **Pets: Guest or visitors** are **not** allowed to bring pets to campground.
- **Alcohol Beverages:** No one **under the legal age** can consume alcoholic beverages in Pine Lane Campground. Site host is legally responsible for anyone under the legal age.
- Overnight guests are allowed one pet. Pets must be kept on a leash, quiet and not left unattended. Pets are not allowed in pool area, play area, or any buildings. Please be kind and scoop all poop. Any dog reported to show aggressive behavior to anyone will be required to be removed by the owner and barred from returning.
- **Firewood:** Not allowed to bring **firewood** into campground. Firewood available for purchase at campground.
- Fireworks and Firearms are prohibited
- Trash: The dumpster is for kitchen garbage only and all garbage must be bagged.
- Swimming Pool: Hours 11 a.m. to 8:30 p.m.
 - **No lifeguard on duty**, swim at your own risk.
 - Swimming pool is locked for the safety of our children. Ask management for key. When you leave pool & no one is in the pool, please **lock gate & return key to management.**
 - Children under 16 years and younger must be accompanied by an adult.
 - Running, pushing, diving, or rough play of any kind is prohibited
 - For your safety, **DO NOT** swim alone
- **Restrooms** – Children **10 and under** must be accompanied by an adult in restrooms.
- All children **16 and under** may not be left in the campground without a responsible adult. All children are the responsibility of their parents, **NOT** their brothers or sisters.
- Curfew is 11 p.m. All children under 18 must be at a campsite supervised by an adult.
- Quiet time is from **11 p.m. to 8 a.m.** – No large gatherings
- No electric heaters and no electric water heaters are permitted.
- Extra charge for air conditioners.
- Erie County Health Department regulations do not permit draining sink or bath water on the ground or into open containers. Violations can result in a large FINE.
- No cleaning fish at campsites. All fish must be cleaned at the fish cleaning station. **Only** fish entrails **must** be deposited in 55 gallon drums at cleaning station! **No Garbage bags!**
- Rowdiness or other disorderly conduct will **not** be tolerated.
- Children 12 and younger and non swimmers must wear **lifejackets** when near the pond. No swimming or wading in the pond.
- **NO ATV's** allowed including children's motorized vehicles
- Anyone caught abusing the camp property **will be asked to leave. No refunds.**
- Pine Lane reserves the right to use any photograph or video taken on Pine Lane property for any use.
- It is understood that Pine Lane is **not responsible** for any damage, theft, or loss of camper's possessions. Camper certifies that they have inspected the site and that the site is safe and fit for their use. Pine Lane, its facilities, its management and camp workers shall be held **harmless** from any act and not responsible for any damages to camper, whether damaged by any virtue of man or act of God. It is also understood that camper is responsible for the acts of their people whether they family or guest, and that all rules, agreements and directions of Pine Lane and/or management must be complied with.
